Petersen (D) – 413\*, State Representative District 11, Gary Worthan (R) – 1625\*, James Eliason (D) – 103, Sara Huddleston (D) – 324\*, County Supervisor District 1, Ranell Drake (R) – 510\*, County Auditor, James W.
