Pre-registered voters are required to provide an approved form of Identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered – such as voters registering to vote on election day – or voters changing precincts MUST also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence, if required) **1)** may have the voter's identity/residence attested to by another registered voter in the precinct, **2)** prove identity and residence using Election Day Registration documents, or **3)** cast a provisional ballot and provide proof of identity/residence at the County Auditor's office by **(date deadline)**. Election Day Registrant attestors must provide an approved form of identification.
