## PERMIT ORDER

1. **FILL OUT** order form on back of envelope.
2. **ENCLOSE** trail fee of \$15 **PER ANNUAL PERMIT** in envelope or enclose \$2 per person for daily permit.
3. **REMIT** envelope by U.S. Mail or drop envelope in the permit tubes located along the trail or the Conservation Education Center.
4. **RETAIN** the receipt portion of the order envelope as proof of purchase during mail order process.
5. **DISPLAY** the receipt portion of the order envelope for **RANGERS** patrolling the trail.
